## OMEA DISTRICT AND STATE SENIOR HIGH SCHOOL BAND, ORCHESTRA AND CHORUS (Mixed, SA, TB)

**ORCHESTRAS:** Classification for orchestras is determined by the grade of music performed. The list for full orchestras and string orchestras is published in the September *TRLAD* each year. Orchestras will perform three compositions. TWO must be from the classification in which the orchestra enters (A, B, or C) and the third composition of the director's own choosing. The selected composition of a full orchestra may be a string orchestra composition.

**BANDS AND CHORUSES:** Classification for bands and choruses is determined by the music selected. The list of required compositions will be published in the September *TRLAD* each year. Bands and choruses will perform three compositions. Directors must choose at least ONE selection from the required list for their district Adjudicated Event. MORE THAN ONE SELECTION MAY BE CHOSED FROM THE REQUIRED LISTS. HOWEVER, ENTRY CLASSIFICATION WILL BE DETERMINED BY THE COMPOSITION FROM THE HIGHEST CLASS CHOSEN. FOR THE STATE LEVEL ADJUDICATED EVENT, AT LEAST ONE SELECTION FROM THE REQUIRED LIST IN WHICH THE BAND OR CHORUS IS ENTERED MUST BE REPLACED BY AN ADDITIONAL SELECTION CHOSEN FROM THE SAME LIST.

**CLASS D:** (District Band-Chorus ONLY): Class D is an open classification for newly organized schools, schools wishing to send a second or third group, and any other schools desiring to use this classification. The following rules must be followed for this classification: (a) Groups in Class D can choose their own music to be performed. There is no required list of compositions for this classification. (b) Three selections must be performed, however, no group is permitted to use any of the required compositions for the current year from any high school Class AA, A, B, or C list. (c) Class D groups ARE NOT ELIGIBLE FOR STATE EVENTS.

**FESTIVAL PERFORMANCE:** Any group, in any *classification (AA-A-B-C)* may enter a large group event in "Festival Performance," performing for written and audible comments only. NO RATING IS GIVEN TO GROUPS IN FESTIVAL PERFORMANCE.

**DEADLINE AND FEES:** The completed band, orchestra, or chorus entry application with a check for the fee, made payable to OMEA MUST be sent by FIRST CLASS MAIL to the local Chair. All entires MUST be postmarked by Saturday, 28 days prior to the Adjudicated Event. Check the September issue of *TRLAD*, or the OMEA web site for the current fee structure. (omea-ohio.org)
